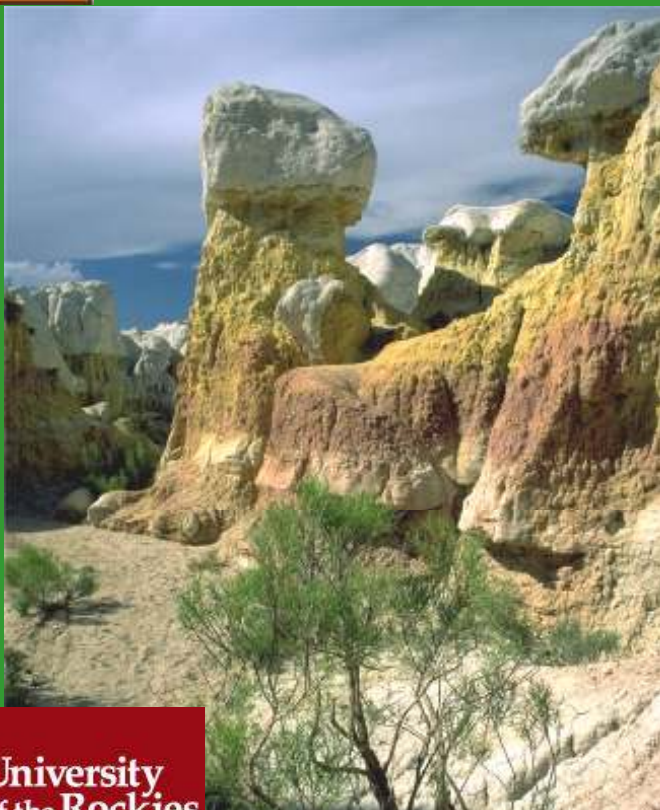


3rd Teva PAINT MINES 6K Race & Fun Run
